Deliberations:

Thereafter, the items on the Agenda were discussed, and the deliberations/recommendations are summarized as under:

Item No. 11.1.0 Confirmation of the minutes of the 10th Meeting of the Building & Works Committee held on 1st July 2005.

Having received no comments, the minutes of the above meeting as recorded and circulated, were confirmed.

Item No. 11.2.0 Action taken Report on the minutes of the 10th Meeting of the Building & Works Committee held on 1st July 2005

Actions taken on the minutes of the above meeting, as given on page 2-4 of the agenda note were noted.

Item No. 11.3.1 To consider the Preliminary Estimate amounting to Rs.86.48 crores as submitted by EIL, New Delhi for Development of the Greater Noida Extension Centre.

At the outset, the representative of the Engineers India Ltd. (EIL), New Delhi made a detailed presentation, on the proposed Extension Centre of the IIT Roorkee at Greater Noida. After consideration of and detailed deliberations on the presentation made by the representative of the EIL, the Building and Works Committee decided that the revised estimate for Development of the Greater Noida Extension Centre on the basis of present needs, should be prepared by the EIL, as per the under-mentioned observation/guidelines:

(a) Convention Centre, Incubation Centre, Guest House, Faculty Rooms, Class Rooms for Continuing Education Programmes, Administrative & Liaison Office, and Security Office should be made in Phase-I.

- (b) Boys Hostel and Group 'A' Officers/Faculty accommodation be made in Phase-II.
- (c) Girls Hostel should be made in Phase-III.
- (d) Development work should also be phased.
- (e) Accommodation required for the essential core subordinate staff be made in an area other than the location of the Group 'A' Officers/Faculty accommodation.
- (f) The entire cost of the project be frozen, and service charges be fixed once for all, once the cost is frozen.
- (g) A three percent margin should be kept in the area of ground coverage, i.e. the ground coverage should be 27%, instead of the maximum permissible 30%.
- (h) The possibility of reduction of cost exists in the Guest House and the Incubation Centre building, which may be looked into and the cost reduced, accordingly.
- (i) The money generated through Phase-I activities, should be utilized for Phases II & III.
- (j) Energy conservation should be adequately catered for.
- (k) The extra cost of Kota Stone flooring and brick cladding should be calculated on the basic cost. Termite Proof Treatment, the cost of fire fighting equipment and the cost of services should not be taken into consideration for arriving at the cost of such flooring/cladding.
- (l) Lump sum estimates should not be given for generators, etc. The actual cost should be given in the estimates.
- (m) The overall project cost should be reduced.
- (n) Service Charges will be 7% of the frozen project cost + 10.2% Service Tax on the service charges.
- (o) A detailed presentation, along with the revised drawings, revised estimates based on the Delhi Schedule of Rates of the CPWD, and the phase wise plan of work, be made by the EIL, in the next meeting of the Board.

Item No.11.3.2 To consider the Preliminary Estimate amounting to Rs. 77.25 lacs for the construction of 75 rooms in Ganga Bhawan.

After discussion, the Committee decided that the Preliminary Estimate amounting to Rs. 77.25 lacs as submitted by the Institute Engineer for construction of 75 additional single seated rooms in the Ganga Bhawan Complex, be accepted in principle with the proviso that the detailed estimates based on plinth area rates and the drawings be prepared and placed before the FC/BOG for specific approval for approval.

Item No. 11.3.3 To consider the Preliminary Estimate amounting to Rs. 23.12 lacs for conversion of the Old Teachers' Hostel into a Girls' Hostel.

After discussion, the Committee decided that the Preliminary Estimate amounting to Rs.23.12 lacs as submitted by the Institute Engineer for conversion of the Old Teachers' Hostel into a Girls' Hostel as given at **Appendix 'A'**, be accepted with the proviso that the additional contingency be charged @ 3% instead of 5%. The same be placed before the FC/BOG for approval.

Item No.11.3.4 To consider the Preliminary Estimate amounting to Rs.5.00 lacs for extension of the Information Superhighway Centre

After discussion, the Committee decided that the Preliminary Estimate of Rs.5.00 lacs for extension of the IMG laboratory in the Information Superhighway Centre as given at **Appendix 'B'** be approved.

Item No.11.3.5 To consider the Preliminary Estimate amounting to Rs.15.00 lacs for replacement of a certain portion of the sewer line in the Azad Wing- Niti Nagar area.

After discussion, the Committee decided that the Preliminary Estimate amounting to Rs.15.00 lacs for replacement of a certain portion of the sewer line in the Azad Wing- Niti Nagar area (Appendix 'C') be accepted. The same be placed before the FC/BOG for specific approval.

Item No.11.3.6 To consider the proposal for engaging one J.E. (Horticulture) on contract, for the Estate & Works Division, IIT Roorkee to look after the lawns and gardens in Departments and Hostels, chargeable to the Non-Plan grant of the Institute.

After discussion, the Committee decided that the proposal for engaging one J.E. (Horticulture) on contract basis at a consolidated remuneration of Rs. 8,000/- p.m., chargeable to the Non-Plan Grant of the Institute, be accepted. The qualifications for the same will be the same as specified in the Modified Assured Career Progression Scheme, which are reproduced below:

Master's degree in Botany with one year of relevant experience.

OR

Bachelor's degree in Botany with three years of relevant experience.

Item No. 11.3.7 Progress report of the on going Major Works.

The progress of the on going Major Works, given at **Appendix 'D'**, was noted with the under mentioned observations:

- 1. The Chief Engineer, CPWD, North Zone II, Lucknow may be informed that;
 - (a) The Construction of 28 Nos. MS Faculty residences: Phase-II be completed by 15.1.2006.
 - (b) The construction work of the Community Centre should be started from 1.1.2006 and the same be completed by 31.10.2006.
- 2. The probable date of completion of the Library Building should be ascertained realistically.
- 3. Maintenance of the MS Faculty residences, should be the highest priority.
- 4. The Main Guest House should be completed by 30th January 2006.
- 5. In future works, no labour colony should be permitted on the Campus. This condition to be included in the NIT.
- 6. The newly constructed MS Faculty Apartments be named 'HILL VIEW APARTMENTS'.

Under Any other item:

Item No.11.3.8 To consider the matter related to construction of the New Boys' Hostel

The Chairman, E & W informed the B&WC that the site for construction of the New Boys' Hostel has been changed to a site near the Ganga-Cautley Bhawan Mess. The B&WC decided that the number of rooms be reduced to 375, but the hostel should have an integral mess. CPWD be requested to reframe the estimates, accordingly. Further, the Nirman Nigam may also be requested to submit the estimate for construction of the said Hostel. The matter be placed before the Finance Committee/Board of Governors for according administrative approval, once the said estimates are made available by the two agencies.

Item No. 11.3.9 To consider the status report on the Central Museum of Engineering and Technology.

Lt. Col. A.K. Srivastava, Registrar and Secretary of the Project Monitoring Group for the Central Museum of Engineering & Technology briefed the committee about the progress of the Museum. After discussion, the Committee decided that a local Architect may be engaged as a consultant to make out the plans for the modifications that would have to be made to the Existing Library Building, to convert it into the said Museum.

The meeting ended with a vote of thanks to the Chair.
