At the outset, the Chairman welcomed the members and thanked them for sparing their time for the meeting.

The agenda was then taken up.

Item No. 39.1: To confirm the minutes of the 38th meeting of the Building & Works Committee held on 27.03.2018.

The minutes of the 38th meeting of the Building & Works Committee held on 27.03.2018 were confirmed.

Item No. 39.2: To receive a report on the action taken to implement the decision of the 38th meeting of Building & Works Committee held on 27.03.2018 and progress report of the on-going projects approved in the earlier meetings of B&WC.

The Building & Works Committee noted the actions taken on the minutes of the 38th meeting and the progress of the on-going projects. In the status report at item no. 37.7, the completion date may be read as 15.02.2019 and at item no. 37.8, the completion date may be read as 28.11.2019.

Item No. 39.3: To consider the proposal for up-gradation of Sport facilities.

The B&WC considered the proposal and recommended the same to FC and BoG with a preliminary estimated cost of Rs. 54.05 crores submitted by CPWD against the preliminary estimate of Rs. 49.00 crores submitted by the consultant.

Item No. 39.4: To consider the proposal for Face Lifting of James Thomason Building at IIT Roorkee campus.

The B&WC noted the status and advised that the proposal for face lifting of James Thomason Building be taken up in a comprehensive manner including retrofitting and strengthening work, if any, to prevent and check structural distresses.

B&WC further desired that a consultant/expert agency may be hired for this work, as soon as possible.

Item No. 39.5: To consider the proposal for construction of underpass under NH58 to connect the Main Campus with Niti Nagar.

The B&WC considered the proposal and recommended the same to FC and BoG with a preliminary estimated amount of Rs. 6.73 crores submitted by CPWD.

Item No. 39.6: To consider the proposal for comprehensive repair and renovation of old eight hostels (Ganga Bhawan, Rajendra Bhawan, Cautley Bhawan, Ravinder Bhawan, Govind Bhawan, Azad Bhawan, Jawahar Bhawan, Sarojani Bhawan).

The B&WC considered the proposal and advised that structural distresses in the buildings, if any, may also be treated. The comprehensive repair work may be taken up keeping in view the life of the existing buildings and ensuring that the building remain fit for purposeful use for at least ten to fifteen years. With these remarks, the proposal was recommended to FC and BoG with a preliminary estimated amount of Rs. 81.16 crores submitted by CPWD.

Item No. 39.7: To consider the proposal for the construction of New Academic blocks.

The B&WC considered the proposal and recommended the same to FC and BoG, including demolition of the existing building(s) wherever applicable, with the preliminary estimates given below:

Item No. 39.8: To consider the proposal for construction of new building for Chemistry Department.

The B&WC considered the proposal and recommended the same to FC and BoG with a preliminary estimated amount of Rs. 89.48 crores submitted by CPWD, including the cost of furniture amounting to Rs. 9.38 Crores.

Further, the B&WC advised that chemical and other hazardous wastes which will be produced from the laboratories in this building be disposed as per the norms and practices recommended by environmental authorities. A common ETP can be planned for Chemistry, Chemical Engineering and Metallurgical & Materials Engineering departments, at some suitable location.



Item No. 39.9: To consider the proposal for Centralized AC Plant with Chiller Technology Phase-I (Architecture & Planning, Civil Engineering and Earth Sciences Department).

The B&WC considered the proposal and observed that a comprehensive plan is required for the execution of Centralized HVAC work in the entire academic area. It was suggested that a Master Plan for a Centralized AC Plant with Chiller Technology be prepared taking into consideration all aspects such as laying of chilled water lines, ducting, locations of AHU, storage of chilled water etc. A HVAC consultant be hired for this purpose and a comprehensive proposal be placed before the B&WC in its next meeting.

Item No. 39.10: To consider the proposal for Centralized Air Conditioning in Institute Instrumentation Centre (IIC)

The B&WC considered the proposal and recommended the same to FC and BoG with an estimated amount of Rs. 2.17 crores with VRV/VRF technology.

The meeting ended with a vote of thanks to the Chair.
