At the outset, the Chairman welcomed the members to the 40<sup>th</sup> Meeting of the Building & Works Committee, with specific reference of the following two new members, who were attending their first meeting and wished for their active participation and valuable contributions in the meetings of B&WC:

The agenda was then taken up.

### Item No. 40.1: To confirm the minutes of 39<sup>th</sup> meeting of the Building & Works Committee held on 28.09.2018.

No comments were received and minutes of the 39<sup>th</sup> meeting of the Building & Works Committee were confirmed.

# Item No. 40.2: To receive a report on the action taken to implement the decision of the 39th meeting of Building & Works Committed held on 28.09.2018 and pending actions on the minutes of the earlier meetings of B&WC.

The Building & Works Committee noted the actions taken on the minutes of the 39<sup>th</sup> meeting and the progress of the on-going projects.

# Item No. 40.3: To consider the proposal for Multi-storied housing for 'B' category staff in Sheel Kunj area.

The B&WC considered the proposal and recommended the same to FC & BoG for preliminary estimated cost of Rs. 46.00 crore. It was suggested that living carpet area in the flat be reviewed as per entitlements norms corresponding to Grade Pay (Pay Level).

## Item No. 40.4: To consider the proposal for housing for Doctors and Paramedical staff in Govindpuri area.

The B&WC considered the proposal and approved the concept plan. Further, it was suggested that consultant services be taken to carry out a survey and work out the details which can be presented before the B&WC.



# Item No. 40.5 Proposal for construction of residential accommodation for Officers and Staff deputed in the Greater Noida Extension Centre (GNEC) Campus, Greater Noida.

The B&WC considered the proposal and approved the same. It was suggested to revise the plan by making a provision of 12 residences with living carpet area as per the entitlement of the respective groups of employees.

# Item No. 40.6: To consider the proposal for construction of residential accommodation for Faculty and Group 'A' Officers in Vikas Nagar (Phase-III).

The B&WC considered the proposal and recommended the same to FC & BoG for a preliminary estimated cost of Rs. 96.00 crore. Further, it was suggested that the provision for parking be reviewed.

# Item No. 40.7: To consider the proposal for construction of 1400 Seater Students' Hostel at Vigyan Kunj

The B&WC considered the proposal and recommended the same to FC & BoG for a preliminary estimated cost of Rs. 180.00 crore. Further recommended that a consultant be appointed to carry out a survey and prepare a detailed project report. In case the proposed hostel is split into two hostels as per site conditions, provision of common mess and other facilities be worked out.

# Item No. 40.8: To consider the proposal for construction of a new academic block near Department of Earth Sciences.

The B&WC considered the proposal having a preliminary estimated cost of Rs. 40.00 crore and recommended the same to FC & BoG.



#### UNDER ANY OTHER ITEM:

Item No. 40.9: To consider the representation of NBCC Ltd regarding clearance of pending dues against final bill of HVAC work in Technology Building at DPT Saharanpur Campus and Multi Activity Centre (MAC) at IIT Roorkee Campus.

The B&WC considered the issue and decided as under:

(a) HVAC work in Technology Building at DPT Saharanpur Campus:

Details of extra work of Rs. 150.91 lacs carried out by NBCC be asked along-with an undertaking from them stating that NBCC has carried out the said work and not claimed the same for payment earlier.

(b) Multi Activity Centre (MAC) at IIT Roorkee Campus:

NBCC has submitted a final bill of Rs. 2703.99 lacs against the sanctioned cost of Rs. 2213.00 lacs. Till date, payment of Rs. 2156.58 lacs has been made to NBCC. The committee was informed that delay in work was on account of the contractor who left the work without completing it. NBCC appointed a new contractor at the risk and cost of the first contractor. PBG of the first contractor was forfeited. Matter is under arbitration. In view of this, it was recommended that an FDR of liquidated amount of Rs. 330.12 lacs be made in the joint name of NBCC and IIT Roorkee till the decision of the arbitrator. Further, B&WC recommended that balance amount of Rs. 217.29 lacs be paid to NBCC.

The meeting ended with a vote of thanks to the Chair.
