

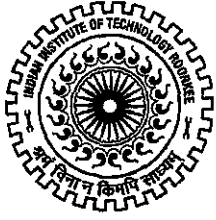



The Chairman (Director) welcomed the members to the 38th Meeting of the Senate.

Due to lack of quorum, the Chairman (Director) ruled that the meeting be adjourned for want of quorum and that the meeting shall be again convened at 4.15 p.m. on the same day.

Accordingly, the Senate meeting was held on 6th May 2011 at 4.15 p.m. at the same venue.

The Senate recorded the communications received from the following members for not attending the meeting:

Before taking up the agenda item, the Director (Chairman) appraised the house about the proposed academic activities to be undertaken at Greater Noida Extension Centre of IIT Roorkee.

The Agenda was then taken up for deliberations:

Item No. 38.1: To consider the Academic Calendar for the Autumn Semester 2011-12.

Senate considered and discussed the proposed Calendar and decided that after incorporating the suggested modifications, the Academic Calendar for the Autumn Semester 2011-12 session as given at **Appendix 'A'** be approved.

Item No.38.2: To consider the Proposal received from Coordinator (Academic), Greater Noida Extension Centre (GNEC) for starting M.Tech. Programmes (Part-time) at GNEC from Autumn Semester 2011-2012 in the Departments of Mechanical & Industrial Engineering, Metallurgical & Materials Engineering, Earthquake Engineering, Water Resource Development & Management and Paper Technology.

The Senate considered the proposal received from the Coordinator (Academic), Greater Noida Extension Centre for starting the M.Tech. programmes (Part-time) at GNEC from the Autumn Semester 2011-2012 in the Mechanical & Industrial Engineering, Metallurgical & Materials Engineering, Earthquake Engineering, Water Resource Development & Management and Paper Technology. After discussion, the Senate decided that the deletions, additions and modifications suggested by the Senators on the floor, be incorporated in the proposal and the same be placed before the Chairman, Senate for approval. The Senate authorised the Chairman, to approve the same on behalf of the Senate.

The Senate further deliberated upon the proposed guidelines to run the Academic Programmes, Short Term Programmes and Industry/ Academics/ Alumini Interaction Programmes at the GNEC and decided as follows:

I. Academic Programs

The M.Tech./MBA programs will be run in part time mode (duration three years). Admissions to the academic programs will be made as per the IIT Roorkee admission norms. The following guidelines be followed to run these programs:

1. Guidelines to run the programs

- a. All programs be run in modular format (part time basis) with extended duration of THREE years. In the first phase only existing M.Tech./MBA programs be run. Minimum duration of each program be THREE YEARS.
- b. All course work be completed in FOUR semesters and number of credits be between 08-12 per semester. Last two semesters be allowed for dissertation work.
- c. Number of programs be decided on the basis of recommendations of the departments/centres and the sufficient number of registrations in the offered programs. No program be run for less than 20 students. Maximum strength in a program is not to exceed 30.
- d. Classes be preferably held during weekends (i.e. Friday (evening), Saturday and Sunday).
- e. Departments are required to appoint one faculty member as a course coordinator for each program being offered and the subject coordinators for various subjects offered in a semester. In case a subject is taught by a guest faculty, the course coordinator is to act as subject coordinator for the same.
- f. Academic rules, procedures and guidelines of IIT Roorkee are to be followed for academic evaluation of the students.
- g. Course/subject coordinators will help the guest faculty in mid-term and end-term evaluations.
- h. Lectures, tutorials and practicals are to be engaged by IITR faculty and guest faculty from NCR.
- i. Course coordinator is to prepare a panel of guest faculty (preferably from NCR). The following criteria should be used while preparing the panel of guest faculty members.
 - i. Existing/former faculty members of IITs/ IIMs/NITs/Central Universities/ Government Engineering Colleges etc.

- ii. Senior working professionals from public and Private Sector undertakings
 - iii. Senior working scientists from R & D and other similar organisations
 - iv. Any other faculty with prior approval of the competent authority
- j. Not more than 50% external experts be involved in teaching of the course as far as possible.
- k. Experts from GoI, R & D organisations and industry may be invited to deliver specialised lectures to the students.
- l. Each week, FOUR to SIX contact hours be engaged by a faculty member. Contact hours may be arranged in blocks of two hours.
- m. Besides normal classroom teaching, lectures/tutorials can also be arranged via video conferencing or as Interactive sessions.
- n. The candidate may also interact with his/her supervisor through e-mails or video conferencing facility. However, the candidate during dissertation is required to meet in person his/her supervisor at least once in two months at his/her own expenses.
- o. Evaluation of M.Tech. dissertation is to be done on similar lines as being done at IIT Roorkee for on campus students.

2. Admissions

- a. Admissions to various programs (M.Tech./MBA) is to be made as per existing IITR rules. The PG Admissions Office will carry out the admission process.
- b. Eligibility requirements and selection procedure for admission to Part Time M.Tech. Programs at the GNEC are to be as per the existing guidelines approved by the Senate.

3. Fee structure

For M.Tech. Program : Rs. 60,000.00 per semester.

For MBA program : Rs.1,00,000.00 per semester.
This fee includes the tuition and other related academic fee only (excluding boarding and lodging).

4. Award of degree

- a. After successful completion of the program the candidate is to be awarded a degree in the respective discipline as per IIT Roorkee rules and regulations.

5. Honorarium and other expenses

- a. Each faculty member shall be paid honorarium and other related expenses as per the IIT Roorkee approved rates. Faculty members of IIT Roorkee shall be treated as external faculty experts for teaching at the GNEC.

II. Short Term Programs

The GNEC has great potential to run successful industry oriented various short term programs. These programs are to be planned and run with the following objectives:

- a. To create opportunity for gaining knowledge and experience in the chosen areas.
- b. To provide a platform for interaction among faculty, consultants, industries and Govt. Departments.

The types of programs to be run at the GNEC include:

- a. Short Term Training Programs (STP)
- b. Entrepreneurship Development Program (EDP)
- c. Quality Improvement Programs (QIP)

The following guidelines are proposed to run these programs:

- a. Short Term Programs and EDP are to be run as a sponsored program, or in consultancy mode, as deemed appropriate.

- b. Training programs are to be conducted by IITR faculty members and guest faculty.
- c. Rules and Regulations of Continuing Education Centre are to be followed to run these programs.

III. Industry/Academia/Alumni Interaction

GNEC is to be used as a platform to interact with industry and academia in NCR for facilitating IITR faculty in their endeavour of excellence in academic and research activities. The following activities in this domain are to be planned at the GNEC.

- a. Networking with various Industry bodies (such as FICCI, CII, ASSOCHAM etc.) and various Govt. Departments (such as CWC, Environment and Forest, NHAI, Surface Transport, Water Resources, Renewable Energy) to facilitate the much needed interaction for the success of offered programs.
- b. Interaction with Software industry, SMEs and Budding Entrepreneurs be given special attention in view of the MoU signed between IITR and UP Govt.
- c. An industry liaisoning cell be setup to promote joint R & D and consultancy activities.
- d. Emphasis be on regular interaction with industry/academia/alumni through seminars and workshops.
- e. Alumni be invited to hold meeting etc. at GNEC to promote much needed bonding.
- f. IITR and industry may jointly start Technology Incubation and Entrepreneurship programs at GNEC.
- g. National and International Conferences/Workshops/Seminars/Symposia etc. be organised at the GNEC to provide a platform for interaction with industry and academia.

Item No.38.3: To consider the proposal received from the Department of Management Studies to start the Part-Time M.B.A. programme at Greater Noida Extension Centre (GNEC).

As considered and recommended by the Board of Studies, the Senate decided that the proposal received from the Department of Management Studies to start a Part-Time M.B.A. programme at GNEC and the minimum eligibility criteria be approved as under:

Minimum Eligibility

- (a) Bachelor's degree in any discipline of Engineering/ Technology with first class or its equivalent, or a Master's degree with first class or equivalent in any discipline from a recognised Institute or University.
- (b) Minimum 3 years of relevant full time work experience in responsible capacity in a registered firm/ company/ industry/ educational and research institute/ govt./quasi govt/autonomous organization.

Selection Basis

- (a) Written test to be followed by Group Discussion (GD) and Interview.
- (b) The weightage for preparing merit list for the admission will be as follows:

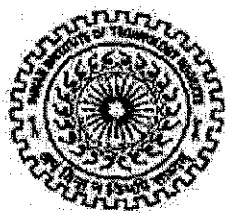

After discussion, the Senate decided that the proposal of Prof. & Head, Department of Biotechnology to add courses from the Departments of Mathematics and the Electronics & Computer Engineering. For this purpose the proposal be referred back to the Head, Department of Biotechnology for obtaining inputs and recommendations in the matter from the respective DFBs of the Departments of Mathematics and the Electronics & Computer Engineering, and then place the matter in the next meeting of the Senate for its consideration.

Item No. 38.5: To consider the request of Prof. P.K. Jain, Coordinator- Academic, Greater Noida Extension Centre (GNEC), to run two M.Tech. programs (a) M.Tech. (Instrumentation and Signal Processing) to be run at GNEC from Electrical Engineering Department (b) M.Tech. (Systems and Control) received vide letter No. IITR/GNEC/922 dated 4.5.2011.

The Senate considered the request of Prof. P.K. Jain, Coordinator (Academic), Greater Noida Extension Centre (GNEC), for starting two M.Tech. programmes (a) Instrumentation and Signal Processing and (b) Systems and Control, at GNEC from Electrical Engineering Department. After discussion, the Senate decided that deletions, additions and modifications suggested by the Senators be incorporated in the proposal and in the information brochure of the GNEC and the same be placed before the Chairman, Senate for approval.
