At the outset, the Chairperson welcomed the under-mentioned new member to the Senate and hoped for his valuable contribution and active participation in its functioning:

The Chairperson also welcomed and thanked the members to the emergent meeting (65th meeting) of the Senate for their participation in the meeting, convened at short notice to discuss the issue related to the tuition fees of Postgraduate M.Tech., M.Sc. & MBA Courses.

Item No. 65.1: To consider the revision of fee structure for M.Tech., M.Sc. and MBA courses.

The Chairperson briefed the status on grants received and expenditure of the Institute with specific reference on fellowship head under Plan Grant. He informed the members about the earlier fee revisions in 1999-2000, 2008-2009 & 2013-2014 and stated that the issue was also considered in the meeting of the Executive Committee of the Senate held on 03.05.2016. The ECS has decided that the matter be recommended for consideration of the Senate, however, the admissions in the Master of Technology courses (self-financing) will be made of the GATE qualified candidates only.

After detailed deliberation, the Senate unanimously decided to propose the under-mentioned fee structure of the M.Tech., M.Sc. and MBA courses:

1.	Master of Technology (M.Tech.) with fellowship	5,000.00	20,000.00
2.	Master of Technology (M.Tech.) without fellowship (Self Finance including sponsored candidates)	25,000.00	1,00,000.00
3.	M.Sc.	3,000.00	20,000.00
4.	Master of Business Administration	1,00,000.00	2,00,000.00

It was also decided that the said fee structure be sent to the Group of Directors and then to the Standing Committee of the IITs Council (SCIC) to make it applicable from the session 2016-2017 in all the IITs unanimously.

The Senate further decided that the 50% seats of M.Tech. be filled with MHRD fellowships and the remaining 50% seats be filled with candidates under self-finance category. These changes will initially be applicable from the academic session 2016-17 to take care of the current deficit in fellowship-head under Plan Grant. The departments were simultaneously requested to come up with proposed ways to generate the resources for payment of fellowships in postgraduate programmes. This will not only be required to address the current financial situation but also be the source for payment of fellowships to the students in the light of future plan and projected financial grants to the Institute from the Government.

The meeting ended with a vote of thanks to the Chair.
